I, _____, an adult, do hereby voluntarily and **irrevocably** relinquish, donate, surrender and release to **Bichon Rescue of Orange County**, hereinafter referred to as **BROC**, the following animal, hereinafter referred to collectively as "Animal".

I have willfully surrendered all medical records and information pertaining to the Animal. BROC has my permission to contact my veterinarian for any additional necessary information pertaining to my Animal, and I hereby consent to the release of any and all medical information by any medical provider.
- I further acknowledge that I am releasing the Animal completely voluntarily and that no representations, considerations or promises of any kind have been made to me by BROC or any of its representatives.
- I understand that by releasing the Animal to BROC, I relinquish all ownership or other interest in the Animal. I will not seek further information about the Animal and will not press BROC for details. My contact with the Animal terminates at the time of surrender. BROC is under no obligation whatsoever to follow up with information about the Animal.
- I hereby release and forever discharge BROC from any and all rights, claims, obligations, liabilities, and causes of action whatsoever arising out of or relating to the ownership, possession, or disposition of the Animal, and I agree to indemnify and hold harmless BROC from and against any and all such rights, claims, obligations, liabilities, and causes of action which may be asserted by third parties.

This is a legally binding document for the irrevocable surrender of your animal for placement with Bichon Rescue of Orange County (BROC). Please read carefully and completely before signing. Take as much time as you need to fully consider this important decision.
